VentureTECH invests RM28m in three Bumiputera technology companies

KUCHING: VentureTECH Sdn Bhd has invested RM28 million in three Bumiputera-led high-growth, high-value (HGHV) companies to support developments in industrial automation, digital inclusion and healthcare innovation.

The investments in Move Robotic Sdn Bhd, Recove Group Sdn Bhd and Edote Sdn Bhd were announced during an Investment Agreement Signing Ceremony held at Pulse Grande Hotel here on Aug 12.

VentureTECH chief executive officer Azizan Jaafar said the investments were focused on companies with innovative technologies that address real-world challenges and strengthen strategic industries.

"At VentureTECH, we invest in companies with innovative technologies that solve real-world challenges, strengthen strategic industries and have the potential to scale sustainably," he said.

He said Move Robotic, Recove and Edote exemplified the type of Bumiputera companies VentureTECH sought to support, combining innovation with commercial potential while delivering socio-economic impact.

Move Robotic provides

warehouse and logistics automation solutions integrating Autonomous Mobile Robots (AMRs), autonomous material-handling solutions, Automated Storage and Retrieval Systems (ASRS), pallet shuttle systems, its Warehouse Management System (WMS) and Robot Fleet Manager (RFM).

Through its Robot-as-a-Service (RaaS) model, the company provides these capabilities under a bundled subscription, supporting implementation and reducing upfront investment requirements.

Recove, meanwhile, is a Med-Tech commercialisation platform focused on transforming research-driven healthcare innovations into market-ready medical technologies.

The company has commercialised NEORUBIN®, a non-invasive newborn jaundice screening device, and is advancing additional medical technologies through its innovation pipeline.

Edote focuses on improving digital accessibility for the visually impaired community through assistive technology.

The company developed eBrelle, described as the first standalone Braille laptop in Malaysia and Southeast Asia,

integrating proprietary hardware, software and accessibility-focused applications into a single platform.

The investment will support Edote in expanding its manufacturing capabilities, strengthening its product portfolio and bringing its assistive technology to more users across Malaysia and the region.

The signing ceremony was witnessed by VentureTECH chairman Datuk Ir Khalilur Rahman Ebrahim, Malaysian Industry-Government Group for High Technology (MIGHT) president and chief executive officer Ts Rushdi Abdul Rahim, Ministry of Economy Deputy Director 2 (Bumiputera Development), Equity Development Division, Dr Haji Hisham Kamal Othman Kamal, and Ministry of Science, Technology and Innovation (MOSTI) Under Secretary, Strategic Planning Division, Puan Rafea'ah Haji Nahar.
